Engineering professors say they are overwhelmed with all the things they currently cover for engineering education. Beth suggested Minnesota becomes one of the first states to require PDH's for climate change. Minnesota became the first state to require Ethics training, now it is national.

MGEC needs to formalize difficulty in hiring, getting all information into one hand out. Vice president Steve Kordosky plans on arguing that ESP and SES's should be higher. In general, many board members believe that the state is not following the law on wage comparison. President Dasenbrock does not believe we should yet have a mediator. Wants to hold off this option until everything has been explained face to face. Economic State budget forecast shows 4.4% and 4.4% for the next two years.
